- ♥ The Junior Handler or Guardian must carry a copy of their signed Junior Handler application while volunteering.

If the above listed Junior Handler is between 16 and 18 years of age, I hereby declare that I am authorized as their guardian to sign this Release of Liability form on their behalf, and understand and agree that they are bound by all terms and conditions of this document.

In consideration of the services provided by LOAL, in connection with the Junior Handler participating in LOAL activities, I as parent/guardian of the Junior Handler agree as follows:

- ♥ I am a certified member in good standing with Love on a Leash.
- ♥ I will accompany the Junior Handler on all LOAL activities and visits.

The Junior Handler, with the consent of the Junior Handler's parents or legal guardian, both referred to hereafter jointly and severally as "Handler", has chosen to participate in Love on a Leash's pet therapy program, referred to hereafter as "LOAL".

Handler understands and agrees that Handler will obey all rules, regulations, and laws of the facilities to be visited. Handler also understands that in the sole discretion of a LOAL representative, a violation of the above may result in an immediate expulsion from LOAL.

In consideration of LOAL accepting Handler into the Program, Handler, her/his heirs, executors, administrators, employers, agents, representatives, insurers and attorneys, hereby releases and discharges LOAL, its officers, agents and representatives (hereafter "released parties") from any and all claims which may arise from any cause whatsoever, including any negligent act or omission by the released parties. The Handler further releases and discharges the released

parties from responsibility for any accident, illness or injury or any other consequences arising or resulting directly or indirectly from Handler's participation in LOAL.

The Handler recognizes and agrees that the released parties assume no responsibility for any liability, damage or injury that may be caused by Handler's negligence or willful acts committed related to or during participation in LOAL, or for any liability, damage or injury caused by the intentional or negligent acts or omissions of any other participant in LOAL, or caused by any other person.

Handler hereby agrees to indemnify and hold harmless the released parties from any loss or liability whatsoever including reasonable attorneys' fees, caused by any act or omission of Handler resulting from direct or indirect participation in LOAL.

It is understood and agreed that if any provision of this Release or the application thereof is held invalid, the invalidity shall not affect other provisions or applications of this Release which can be given effect without the invalid provisions or applications and to this end the provisions of this Release are declared severable.

The language of all parts of this Release shall in all cases be construed as a whole, according to its fair meaning, and not strictly for or against any party.
