Dear Team-in-Training,

As life begins to return to a new normal at varying rates around the country, we acknowledge that some teams-in-training have missed the 12-month deadline to complete their 10 supervised visits as a result of visit suspensions. We hope that you or your local chapter leader/supervisor have been tracking local facilities' closures. Once facilities in your area allow visits to resume, please endeavor to complete your supervised visits as quickly as you feel safe doing so. If your one-year mark is fast approaching, or has elapsed due to facility closures, isolation mandates, or health concerns, Love on a Leash will grant an extension on a case-by-case basis.

<u>Extension eligibility</u>: Teams must have completed at least one (1) supervised visit before visits were suspended. Teams who passed their Control Evaluation but were unable to begin Supervised Visits, are not eligible for a visit extension. These teams must retake their Control Evaluation first. This is for safety and insurance purposes.

Please complete the attached form to request an extension to your one-year Supervised Visits time allotment. **Please only submit** *after* **you** (and your supervisor) **have a** <u>confirmed</u> <u>date</u> **to resume visits.**

- 1. Complete and submit (scan/photo and email) to National LOAL at assistant@loveonaleash.org or mail a paper copy to LOAL, Attn: Martina Sullivan.
- 2. National LOAL will confirm receipt & eligibility, determine a new deadline, grant an extension, and return the form indicating the new deadline date within 48 hours.
